

## SECURE AND FAIR ENFORCEMENT FOR MORTGAGE LICENSING ACT-NMLS NUMBERS

The Secure and Fair Enforcement Act for Mortgage Licensing Act (SAFE Act) requires banks, mortgage loan originators and their employing institutions to register with the Nationwide Mortgage Licensing System & Registry (NMLS).
